**ORDER ON FINAL HEARING, FINAL CERTIFICATION OF THE UNOCAL  
SETTLEMENT CLASS, AND APPROVAL OF THE UNOCAL CLASS SETTLEMENT**

---

Pursuant to the Court's *Order on Plaintiffs' Motion For Preliminary Approval Hearing and Provisional Certification of the Unocal Settlement Class* and the *Notice of Pendency of Class Action Proposed Settlement With Defendant Union Oil Company of California d/b/a UNOCAL* sent to each potential class member, a final hearing on the reasonableness and fairness of the proposed settlement in this action was held on March 5, 2004, in Green River, Wyoming. At the hearing, Cody L. Balzer represented the Plaintiff and appeared as Class Counsel, while Andrew L. Pickens and Philip T. Bruns, represented and appeared on behalf of Union Oil Company of California d/b/a Unocal ("Unocal").

Pursuant to Wyo.R.Civ.P. 23 and 54, the COURT FINDS AND ORDERS AS FOLLOWS:

1. Plaintiff filed a suit against Unocal alleging individual claims and class action claims seeking, among other things, declaratory and compensatory relief. Plaintiffs sought certification of a class, including Plaintiff, under Wyo.R.Civ.P. 23(b)(2) and (b)(3) for declaratory relief and for money damages.

2. Unocal and the Plaintiff agreed to settle this action on the terms now memorialized in the Settlement Agreement, executed by and between the parties on December 10, 2003 (the "Settlement Agreement"). The Settlement Agreement is attached to Plaintiff's *Motion for Preliminary Hearing and Provisional Certification of the Unocal Settlement Class* as Exhibit 1, and incorporated fully herein. All capitalized terms used in this Order and not defined herein shall have the meanings set forth in the Settlement Agreement. In the event of any conflict between the descriptions in these paragraphs and the more detailed terms of the Settlement Agreement, the Settlement Agreement shall govern.

3. This suit involves claims brought under Wyoming Royalty Payment Act, Wyo. Stat. §§ 30-5-301, et seq. for Disputed Deductions Claims, Undervaluation Claims, Statutory Interest Claims, Statutory Reporting Assessments Claims and Attorneys' Fees Claims as those terms are defined in the Settlement Agreement.

4. The Court has jurisdiction and venue over this suit and the Settlement Class. Under Wyo.R.Civ.P. 23(e), approval of this Court is required for any settlement and dismissal of this action.

Certification of the Settlement Class

5. The All Claims as defined in the Settlement Agreement all arise from the same nucleus of operative facts and form part of the same case or controversy as alleged against Unocal in Plaintiff's Complaint so that all of the claims approved for settlement by this Order were or could have been asserted as class claims in this Action.
6. The Settlement Class Members are so numerous that joinder is impractical.
7. There are questions of law and fact common to the Settlement Class Members and Plaintiff.
8. The questions of law and fact common to the Settlement Class Members predominate over any questions affecting only individual members, and a settlement of Settlement Class Members' claims by a class action under Wyo.R.Civ.P. 23 is superior to other available methods for the fair and effective settlement and adjudication of the controversy.
9. Plaintiff's claims are typical of the Settlement Class Members' claims.
10. Plaintiff is an appropriate representative of the Settlement Class and has and will fairly and adequately represent the interests of the Settlement Class Members.
11. Settlement Class Members have no special interest in individually controlling the prosecution of separate actions.
12. Class Counsel is experienced and fully qualified.
13. No significant difficulties are likely to be encountered in the management of the action as a class action for settlement purposes.
14. The Court hereby certifies as members of the Settlement Class the list of Royalty Payees set forth in Exhibit A to this Order. This list includes all Royalty Payees

who have not opted out of the class by filing a timely notice of their request to be excluded from the Settlement Class or were not excluded as not satisfying the class definition. Set forth in Exhibit B are those Royalty Payees who have opted out of the class by notifying the Court of their election to be excluded from the Settlement Class and have not timely revoked their election, or with respect to Hondo Oil & Gas Co., were excluded by Class Counsel and Unocal as not satisfying the Class definition.

Notice of Pendency of the Class Action Proposed Settlement And Hearing

15. Pursuant to the *Order on Plaintiff's Motion for Preliminary Hearing and Provisional Certification of the Unocal Settlement Class*, and Wyo.R.Civ.P. 23(e), Class Counsel provided notice to the parties listed on Exhibits A and B of the compromise and settlement reached in this action (the "Notice"). A copy of the Notice is attached as Exhibit 2 to Plaintiff's *Motion for Preliminary Hearing and Provisional Certification of the Unocal Settlement Class*.

16. According to the *Class Counsel's Report on Status of Class Notice Pursuant to Wyo.R.Civ.P. 23(c)(2)* filed with this Court by Class Counsel ("Class Counsel's Report") the Notice was sent via certified mail to all parties listed on Exhibits A and B. *Class Counsel's Report* confirms (1) zero objections and two opt-outs were filed to the Class Settlement, (2) four hundred eleven (411) Royalty Payees remained as Settlement Class Members and (3) two owners were removed by Class Counsel and Unocal from the class list due to a determination they did not satisfy the class definition as they were working interest owners.

17. Reasonable and adequate notice of the certification of the Settlement Class and the settlement of the Settlement Class Members' Settled Claims was given through

mailing of the Notice as approved in the Court's *Order on Plaintiff's Motion for Preliminary Hearing and Provisional Certification of the Unocal Settlement Class*.

Approval of the Settlement Agreement

18. The settlement was made in good faith.
19. The settlement constitutes a fair, adequate and reasonable settlement of all the settled All Claims.
20. This Court finds after considering all the circumstances that the Settlement Agreement is fair and equitable and should be approved.

NOW, THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED THAT:

- a. The Settlement Class Members listed in Exhibit A are certified as a class under Wyo.R.Civ.P. 23 for purposes of settlement only of the settled All Claims, and shall proceed with settlement as provided in this Order;
- b. As of the Approval Event, any Settlement Class Member who has not timely and properly opted out of the Settlement Class shall be deemed, by that fact, to have released Unocal as provided in the Settlement Agreement whether or not the Settlement Class Member endorses and presents a Distribution Check;
- c. Following the Approval Event, each Settlement Class Member as defined shall become fully bound by all of the releases and other obligations and conditions as set forth herein and in the Settlement Agreement;
- d. Except as necessary to enforce this Order and the Settlement Agreement, Plaintiff, Settlement Class Members and their heirs, personal representatives,

assigns, and successors are barred from bringing claims against Unocal for the settled All Claims as set forth in the Settlement Agreement.

e. Unocal has escrowed with the Hilltop National Bank of Casper, N.A. ("Escrow Agent") the sum of Two Hundred Fifty Thousand Dollars (US\$250,000) ("Escrow Amount") in accordance with the Settlement Agreement

f. The date of distribution of the Escrow Amount shall be Tuesday, March 9, 2004.

g. The Escrow Amount shall have accrued interest in the amount of Three Hundred Ninety Two Dollars and Two Cents (\$392.02) through the date of distribution. All such interest should be payable to Settlement Class Members less the reasonable and actual fees of the Escrow Agent. Class Counsel should receive no portion of the interest.

h. The aggregate amount to be paid from the Escrow Amount to Plaintiff and Settlement Class Members, including interest, is and shall be One Hundred Sixty Five Thousand Three Hundred Two Dollars and Eighty-five Cents (\$165,302.85) ("Settlement Amount"), which aggregate sum shall be paid to Class Members in the amounts as set forth in Exhibit C to this Order.

i. The reasonable fees of Class Counsel are and shall be Seventy Five Thousand Dollars (\$75,000.00) ("Permissible Class Counsel Fees"), which amount shall be paid to Class Counsel. The reasonable litigation costs are and shall be Five Thousand Dollars (\$5,000.00) ("Litigation Costs)."

j. The total reasonable fees and costs of the Class Representative is and shall be Five Thousand Dollars (\$5,000.00) ("Permissible Class Representatives Fees"), which amount shall be paid to the Class Representative from the Escrow Amount.

k. Upon entry of this Order, and satisfaction of the Approval Event, as that term is defined in the Settlement Agreement, Unocal and Class Counsel shall instruct the Escrow Agent to release from the Escrow Account all funds to be paid according to the Settlement Agreement. This amount will be released per the Settlement Agreement to pay the amounts to be distributed to Settlement Class Members, the Permissible Class Counsel Fees, Litigation Costs and to refund of Eighty Nine Dollars and Sixteen Cents (\$89.16) to Unocal that portion of the Escrowed Amount attributable to those sums that would have been paid to Potential Class Members listed in Exhibit B (other than Hondo) to this Order who have requested to be excluded from the Settlement Class.

l. No funds will remain in the Escrow Amount after release of the funds and the refund to Unocal.

m. Upon entry of this Order, and satisfaction of the Approval Event, as that term is defined in the Settlement Agreement, the Reserved Claims as that term is defined in the Settlement Agreement will be deemed severed from the All Claims and will be dismissed without prejudice upon motion by the Parties in accordance with the Settlement Agreement.

n. Upon entry of this Order, and satisfaction of the Approval Event, as that term is defined in the Settlement Agreement, Class Counsel and Defendant shall file a stipulated satisfaction and order of dismissal with prejudice of all the settled All Claims. The order of dismissal with prejudice of the settled All Claims shall be entered by the

Court and shall be considered a final appealable order under Wyo.R.Civ.P. 54. To the extent such may be necessary in light of the Reserved Claims, this Order is hereby certified as final and appealable under Wyo.R.Civ.P. 54(b).
